## Fixtures & Lamps Limited Warranty

Unless otherwise stated in writing by LEDdynamics, Inc. (LDI), LDI warrants that its Fixtures (the "Product") will be free from defects in materials and workmanship from the date of purchase for a period of one (5) years; its EverLED TR T8 Lamps (the "Product") will be free from defects in materials and workmanship from the date of purchase for a period of ten (10) years; and its EverLED VE and XO T8 Lamps (the "Product") will be free from defects in materials and workmanship from the date of purchase for a period of ten (10) years; and its EverLED VE and XO T8 Lamps (the "Product") will be free from defects in materials and workmanship from the date of purchase for a period of five (5) years. Products under this warranty include:

Fixtures – LVL2 and LVL 4;

T8 Lamps – EverLED TR, EverLED VE and EverLED XO;

If a Product fails to operate during the warranty period as a result of defects in materials or workmanship, LDI will at its sole option, will repair or replace with the same or like Product at no charge.

To establish a claim under this Limited Warranty, LDI may require by issuance of a Return Authorization Number (RMA) the return of the Product claimed to be defective to a facility designated by LDI. All costs of transportation of the Product and of any repaired or replacement Product to or from such facility shall be borne solely by Buyer. The cost of labor for removing a Product and for installing a repaired or replacement Product shall be the sole responsibility of the Buyer and under no circumstance shall LDI be responsible for labor costs required in the product removal, installation or re-installation process.

Any repaired Products or replaced Products, shall be covered under this Limited Warranty for the time period remaining under the original purchase warranty period or for a period of 90 days; whichever is longer.

**Original Purchaser**: This warranty is extended to the original Buyer only and with proof of purchase. However, in the event that a valid warranty claim has been made to the original Buyer by its customers, LDI will honor those claims pursuant to the terms of its warranty as set forth herein.
